## **Funding Opportunities**

### **[Affordable Housing for Rural Veterans Initiative](#) \*NEW\***

Funding for "bricks and mortar" projects that assist low-income, elderly, and disabled veterans with home repair needs, support homeless veterans, help veterans become homeowners, and/or secure affordable rental housing in **rural** areas of the United States.

**Application Deadline: January 22, 2024**

### **[Community Connect Broadband Grant Program](#) \*NEW\***

Grants for communities without broadband access to provide residential and business broadband service and connect facilities such as police and fire stations, healthcare, libraries, and schools.

**Application Deadline: February 20, 2024**

### **[Service Area Competition - Additional Area Funding for Health Center Program \(Project Period Start Date of August 1, 2024\)](#) \*NEW\***

Funding to provide comprehensive primary healthcare services to an underserved area or population. Areas with an August 1, 2024 project period start date are eligible to apply.

**Application Deadline: February 20, 2024**

**Primary Care Training and Enhancement: Physician Assistant Rural Training in Behavioral Health (PCTE-PARB) Program \*NEW\***

Funding to train primary care physician assistants to prevent, identify, diagnose, treat, and refer services for behavioral health conditions. The program goal is to increase the number of trained physician assistants who choose to practice in **rural** areas after graduation.

**Application Deadline: March 15, 2024**

**State Maternal Health Innovation \*NEW\***

Funding to reduce maternal mortality and severe maternal morbidity in states, including for populations experiencing disparities in maternal health outcomes.

**Application Deadline: April 2, 2024**

**Nurse Faculty Loan Program**

The Nurse Faculty Loan Program (NFLP) provides funding for accredited schools of nursing to establish and/or operate a student loan fund. Grantees will loan money to students, and up to 85% of each loan may be forgiven upon completion of up to 4 years of full-time employment as a faculty member in an accredited school of nursing.

**Application Deadline: February 5, 2024**

**Summer Health Professions Education Program**

A free summer enrichment program designed to improve access to information and resources for college students interested in the health professions.

**Application Deadline: February 5, 2024**

**Section 811 Supportive Housing for Persons with Disabilities**

Capital advance funding for the development of permanent supportive rental housing. Housing must be for very-low-income persons with disabilities who are between 18-62 years of age at entry. Projects from **rural** and tribal areas are encouraged.

**Application Deadline: February 12, 2024**

**Rural Residency Planning and Development Program**

Grants to develop newly accredited, sustainable **rural** residency programs in family medicine, internal medicine, public health, general preventive medicine, psychiatry, general surgery, and obstetrics/gynecology. The overall goal of the program is to support expansion of the physician workforce in rural communities.

**Application Deadline: February 12, 2024**

**Grants for Expansion and Sustainability of the Comprehensive Community Mental Health Services for Children with Serious Emotional Disturbances**

Grants to improve the mental health outcomes for children and youth, birth through age 21, at risk for or with serious emotional disturbances (SED), and their families. **Rural** and tribal populations are priorities, among others.

**Application Deadline: February 14, 2024**

**Geriatric Workforce Enhancement Program**

Grants to educate and train the primary care and geriatrics workforces to provide age-friendly and dementia-friendly care in integrated geriatrics and primary care sites/delivery systems and maximize patient and family engagement to address care gaps and improve health outcomes for older adults. Proposals that benefit older adults in **rural** or other underserved communities/populations are a priority.

**Application Deadline: February 26, 2024**

**The Gus Schumacher Nutrition Incentive Program - Produce Prescription Program**

Funding to support projects that demonstrate and evaluate the impact of prescribing fresh fruits and vegetables on the improvement of dietary health through increased consumption of fruits and vegetables, the reduction of individual and household food insecurity, and the reduction in healthcare use and associated costs.

**Application Deadline: February 28, 2024**

**Rural Business Development Grants**

Supports targeted technical assistance, training, and other activities leading to the development or expansion of small and emerging private businesses in **rural** areas that have fewer than 50 employees and less than \$1,000,000 in gross revenues.

**Application Deadline: February 28, 2024**

### **ELEVATE: Internships at ARC**

ELEVATE is a paid summer internship opportunity where Appalachian students and recent graduates can elevate their careers, cultivate a deeper connection to the region, and innovate through meaningful projects that will impact their communities.

**Application Deadline: February 29, 2024**

### **VA Quality Scholars Fellowship**

Two-year residential fellowship for clinicians who are interested in making veteran healthcare equitable and accessible for marginalized and rural populations. Fellows split their time between in-person clinical work, independent studies, and structured didactics while guided by a set of experienced mentors.

**Application Deadline: March 1, 2024**

### **Notice of Special Interest (NOSI): Telehealth in Cancer Care**

Notice of Special Interest for research on the use of telehealth in cancer-related care, with a focus on populations that experience inequities in access to care and have worse cancer outcomes compared to the general population.

**Application Deadline: March 8, 2024**

### **SAMHSA Minority Fellowship**

A 1-year fellowship for psychiatry residents who are interested in addressing minority psychiatric mental health issues and committed to a career providing culturally sensitive psychiatric services for minority underserved populations.

**Application Deadline: March 15, 2024**

### **American Psychiatric Association Diversity Leadership Fellowship**

A 2-year fellowship for minority psychiatry residents or those interested in minority and vulnerable populations. Activities are designed to prepare residents to teach, administer, and provide culturally competent, evidence based mental health and substance abuse services for diverse minority groups and at-risk populations.

**Application Deadline: March 15, 2024**

### **Physician Assistant Rural Training in Behavioral Health Program**

The purpose of the Primary Care Training and Enhancement- Physician Assistant Rural Training in Behavioral Health program is to develop clinical rotations for primary care physician assistant students in **rural** areas. The goal is to increase the number of physician assistants trained to deliver these services in rural areas, including Medications for Opioid Use Disorder.

**Application Deadline: March 15, 2024**

### **Rural Emergency Medical Services Training Grant**

Grants to recruit and train emergency medical services personnel in **rural** areas with a focus on addressing substance use disorders and co-occurring mental health conditions.

**Application Deadline: March 20, 2024**

### **American Hospital Association Next Generation Leaders Fellowship**

A fellowship program designed to empower healthcare leaders to bring about lasting change in the hospital and health systems in which they serve. **Rural** applicants are encouraged.

**Application Deadline: March 29, 2024**

### **Rural Health Care Telecommunications (Telecom) Program**

Assistance to healthcare providers for eligible expenses related to telecommunications and voice services for the use of telemedicine and telehealth.

**Application Deadline: April 1, 2024**

### **Rural Health Care Program – Healthcare Connect Fund**

Provides assistance to healthcare providers for eligible expenses related to broadband connectivity at a flat discounted rate of 65%. Participants can apply as a member of a consortium or a stand-alone entity.

**Application Deadline: April 1, 2024**

### **State Maternal Health Innovation Program**

The purpose of the State Maternal Health Innovation program is to reduce maternal mortality and severe maternal morbidity by: improving access to care that is comprehensive, high-quality, appropriate, and on-going throughout the preconception,

prenatal, labor and delivery, and postpartum periods; enhancing state maternal health surveillance and data capacity; and identifying and implementing innovative interventions to improve outcomes for populations disproportionately impacted by maternal mortality and severe maternal morbidity.

**Application Deadline: April 2, 2024**

**[Technology Development to Reduce Health Disparities \(R01 Clinical Trial Optional\)](#)**

Funding to develop and translate medical technologies aimed at reducing disparities in healthcare access and health outcomes. Medical technologies should be effective, affordable, culturally acceptable, and deliverable to those who need them. Priority health disparity populations include racial and ethnic minorities, socioeconomically disadvantaged individuals, sexual and gender minorities, and medically underserved populations in **rural** and urban areas.

**Application Deadline: May 2, 2024**

**[Notice of Special Interest \(NOSI\): Research on the Impact of the COVID-19 Pandemic and Risks for Abuse and Injury Among Vulnerable Children and Youth](#)**

Notice of Special Interest to fund research on the impact of the COVID-19 pandemic and risks for abuse and injury among vulnerable children and youth. Emphasis is placed on disparity populations related to abuse and neglect prior to the pandemic, as well as populations that have been disproportionately affected by the coronavirus. Disparity populations include LGBT youth and children seen at **rural** emergency departments.

Notice of Special Interest for dissemination and implementation research to support innovative approaches to overcoming barriers to the adoption, adaptation, integration, scale-up, and sustainability of evidence-based interventions to support children's mental, emotional, and behavioral health in school settings. Health disparity populations, including individuals living in **rural** areas, are a priority.

**[AHRQ Health Services Research Projects](#)**

Support for specified health services research projects related to AHRQ's mission to produce evidence to make healthcare safer, higher quality, more accessible, equitable, and affordable. AHRQ's priorities include an interest in **rural** and frontier healthcare delivery.

**[AHRQ Small Research Grant Program](#)**
