## <u>Delivery of medications by drone on Virginia's Eastern Shore successful,</u> <u>Tangier may be next</u>

The project marks a significant step forward in using drone technology to improve access to healthcare resources and enhance patient care by delivering medications straight to the patient's doorstep by drone. The team delivered three successful packages to three patients within two miles of Riverside Shore Memorial Hospital in Onancock, Virginia.

After this successful first patient delivery, the team plans to demonstrate more extensive and further-distance delivery and beyond visual line of site operations, eventually delivering to remote Tangier Island in the middle of the Chesapeake Bay.

**VRHA Board Member Nick Chuquín, President of Riverside Shore Memorial Hospital**, added, "Ensuring our patients have access to their essential medications is a top priority for Riverside. This collaborative project helps to improve our patients' health and quality of life by increasing medication adherence and removing transportation barriers. We are also focused on safety in all aspects: keeping the medications safe, such as temperature ranges, chain of custody, and double checks to make sure the right patient gets the right medication."

#### The opioid epidemic cost Virginians \$5 billion in 2021, new data shows

Last year, Virginia Commonwealth University's Center on Society and Health collaborated with the Virginia Department of Health to calculate how much the opioid epidemic cost

Virginians financially in 2020, including families, businesses and government agencies. New data collection methods introduced in 2021 now suggest that the prevalence and economic impact of opioid addiction was underestimated in previous reports.

The data from 2021 revealed that nearly 150,000 people in Virginia had an opioid use disorder, 127% higher than 2020 estimates, with at least six Virginians dying of an opioid drug overdose every day on average. The calculator revealed that the overall cost of the epidemic in 2021 was more than \$5 billion, which is 43% higher than 2020 estimates. On an individual level, the financial impact of the opioid epidemic amounted to \$588 per Virginian on average.

The increased reports of opioid use in 2021 were in part due to changes in the NSDUH's survey methods to provide a more accurate estimate of the epidemic's impact. In the 2020 survey, questions about substance use disorder were given only to individuals who abused prescription drugs, such as taking them for longer periods of time or in larger amounts than what was prescribed. However, even when prescription drugs are used as intended, people can still be at risk of developing addiction.

# CHS Seeds for Stewardship Grants \*NEW\*

Matching grants to cooperatives for programs to strengthen hometown communities, with priority given to projects that enhance agriculture safety, farmer well-being, agriculture education, and **rural** community vitality.

# AARP Community Challenge \*NEW\*

Grants for projects that work to improve livability for all residents of a community. #### Stand Down Grants \*NEW\*
