### **[Appalachia READY Local Governments Training](#) \*NEW\***

Training to help local government officials in the Appalachian region better identify, secure, manage, and implement federally funded projects.

**Application Deadline: February 29, 2024**

### **[Nurse Corps Loan Repayment Program](#) \*NEW\***

Loan repayment assistance for registered nurses, nurse practitioners, advanced practice nurses, and nursing school faculty who agree to work at a Critical Shortage Facility or an eligible school of nursing.

**Application Deadline: March 7, 2024**

### **[Reeve Foundation Quality of Life Grants](#) \*NEW\***

Grants to nonprofit organizations that provide services to improve the daily lives of people with paralysis and their caregivers. Projects and initiatives should foster inclusion, community engagement, and health and wellness.

**Application Deadline: March 8, 2024**

**Grants to Expand Substance Abuse Treatment Capacity in Adult and Family Treatment Drug Courts \*NEW\***

Grants to enhance and expand substance use disorder treatment services in existing drug courts, recognizing the need for treatment instead of incarceration for individuals with substance use disorders.

**Application Deadline: April 1, 2024**

**Staff Sergeant Fox Suicide Prevention Grants \*NEW\***

Community-based grants for eligible entities to provide, or coordinate the provision of, suicide prevention services to eligible veterans and their families. Priority is given to **rural** communities, tribal lands, and medically underserved areas.

**Application Deadline: April 26, 2024**

**AARP Community Challenge**

Grants for projects that work to improve livability for all residents of a community. The 2023 application cycle will focus on public spaces; housing; transportation; civic engagement; diversity, equity, and inclusion; digital connections; community health; and economic empowerment, among others. Applications from **rural** communities are encouraged.

**Application Deadline: March 6, 2024**

**Continuum of Care Program Collaborative Applicant Registration**

The Continuum of Care Program provides grants for community collaboration projects that assist individuals and families who are homeless by providing supportive care services, transitional housing, and permanent housing. Projects must designate a collaborative applicant and successfully complete a collaborative registration process to be eligible to apply for funding.

**Application Deadline: March 7, 2024**

**Notice of Special Interest (NOSI): Telehealth in Cancer Care**

Notice of Special Interest for research on the use of telehealth in cancer-related care, with a focus on populations that experience inequities in access to care and have worse cancer outcomes compared to the general population.

**Application Deadline: March 8, 2024**

**[SAMHSA Minority Fellowship](#)**

A 1-year fellowship for psychiatry residents who are interested in addressing minority psychiatric mental health issues and committed to a career providing culturally sensitive psychiatric services for minority underserved populations.

**Application Deadline: March 15, 2024**

**[American Psychiatric Association Diversity Leadership Fellowship](#)**

A 2-year fellowship for minority psychiatry residents or those interested in minority and vulnerable populations. Activities are designed to prepare residents to teach, administer, and provide culturally competent, evidence based mental health and substance abuse services for diverse minority groups and at-risk populations.

**Application Deadline: March 15, 2024**

**[Physician Assistant Rural Training in Behavioral Health Program](#)**

The purpose of the Primary Care Training and Enhancement- Physician Assistant Rural Training in Behavioral Health program is to develop clinical rotations for primary care physician assistant students in **rural** areas. The goal is to increase the number of physician assistants trained to deliver these services in rural areas, including Medications for Opioid Use Disorder.

**Application Deadline: March 15, 2024**

**[Primary Care Training and Enhancement: Physician Assistant Rural Training in Behavioral Health \(PCTE-PARB\) Program](#)**

Funding to train primary care physician assistants to prevent, identify, diagnose, treat, and refer services for behavioral health conditions. The program goal is to increase the number of trained physician assistants who choose to practice in **rural** areas after graduation.

**Application Deadline: March 15, 2024**

**[American College of Lifestyle Medicine HEAL Scholarship Program](#)**

A scholarship for clinicians who are underrepresented in medicine to assist with the costs associated with attaining education and certification in lifestyle medicine.

**Application Deadline: March 17, 2024**

**States Advancing All-Payer Health Equity Approaches & Development Model**

A state total cost of care (TCOC) model that works to drive state and regional healthcare transformation and multi-payer alignment, with the goal of improving the total health of a state population and lowering costs. The AHEAD Model will provide participating states with funding and other tools to address rising healthcare costs and support health equity.

**Application Deadline: March 18, 2024**

**Rural Emergency Medical Services Training Grant**

Grants to recruit and train emergency medical services personnel in **rural** areas with a focus on addressing substance use disorders and co-occurring mental health conditions.

**Application Deadline: March 20, 2024**

**Behavioral Health Integration Evidence Based Telehealth Network Program**

Funding to support evidence-based projects that utilize telehealth technologies through telehealth networks to integrate behavioral health services into primary care settings in **rural** and underserved areas.

**Application Deadline: March 22, 2024**

**Transformative Research to Address Health Disparities and Advance Health Equity**

Funding to support innovative intervention research addressing social determinants of health (SDOH) which, if successful, would have a major impact on preventing, reducing, or eliminating health disparities and advancing health equity. **Rural** populations are a priority, among other populations.

**Application Deadline: March 22, 2024**

**American Hospital Association Next Generation Leaders Fellowship**

A fellowship program designed to empower healthcare leaders to bring about lasting change in the hospital and health systems in which they serve. **Rural** applicants are encouraged.

**Application Deadline: March 29, 2024**

### **Rural Health Care Telecommunications (Telecom) Program**

Assistance to healthcare providers for eligible expenses related to telecommunications and voice services for the use of telemedicine and telehealth.

**Application Deadline: April 1, 2024**

### **Rural Health Care Program – Healthcare Connect Fund**

Provides assistance to healthcare providers for eligible expenses related to broadband connectivity at a flat discounted rate of 65%. Participants can apply as a member of a consortium or a stand-alone entity.

**Application Deadline: April 1, 2024**

### **State Maternal Health Innovation**

Funding to reduce maternal mortality and severe maternal morbidity in states, including for populations experiencing disparities in maternal health outcomes.

**Application Deadline: April 2, 2024**

### **PCORI Engagement Award: Capacity Building**

Funds projects that encourage the integration of patients, caregivers, clinicians, and other stakeholders as members of the patient-centered clinical effectiveness research process.

**Letter of Intent (Required): April 4, 2024**

**Application Deadline: July 10, 2024**

### **Medicare Rural Hospital Flexibility Program**

Grants to state designated entities to assist Critical Access Hospitals with quality and performance activities, including: stabilizing **rural** hospital finance; integrating emergency medical services (EMS) into their healthcare systems; incorporating population health; and fostering innovative models of healthcare.

**Application Deadline: April 16, 2024**

### **Technology Development to Reduce Health Disparities (RO1 Clinical Trial Optional)**



Funding to develop and translate medical technologies aimed at reducing disparities in healthcare access and health outcomes. Medical technologies should be effective, affordable, culturally acceptable, and deliverable to those who need them. Priority health disparity populations include racial and ethnic minorities, socioeconomically disadvantaged individuals, sexual and gender minorities, and medically underserved populations in **rural** and urban areas.

**Application Deadline: May 2, 2024**

**[Notice of Special Interest \(NOSI\): Research on the Impact of the COVID-19 Pandemic and Risks for Abuse and Injury Among Vulnerable Children and Youth](#)**

Notice of Special Interest to fund research on the impact of the COVID-19 pandemic and risks for abuse and injury among vulnerable children and youth. Emphasis is placed on disparity populations related to abuse and neglect prior to the pandemic, as well as populations that have been disproportionately affected by the coronavirus. Disparity populations include LGBT youth and children seen at **rural** emergency departments.

**[AHRQ Safety Program for Telemedicine](#)**

Free learning cohorts of healthcare professionals who use telemedicine as a care delivery model. The 2024 cohort will begin in June 2024 and will focus on appropriate antibiotic use while maintaining patient satisfaction and reducing potential side effects in patients seen via telemedicine. Providers and practices from **rural** communities are encouraged to apply.

Disparity populations include American Indians, Alaska Natives, LGBT youth, and children seen at **rural** emergency departments.

Notice of Special Interest for dissemination and implementation research to support innovative approaches to overcoming barriers to the adoption, adaptation, integration, scale-up, and sustainability of evidence-based interventions to support children's mental, emotional, and behavioral health in school settings. Health disparity populations, including individuals living in **rural** areas, are a priority.

**[AHRQ Health Services Research Projects](#)**

Support for specified health services research projects related to AHRQ's mission to produce evidence to make healthcare safer, higher quality, more accessible, equitable, and affordable. AHRQ's priorities include an interest in **rural** and frontier healthcare delivery.

**Stand Down Grants**
